- A dealer or an agent or employee of a dealer who is convicted of a felony under Section 9, Article II of the Bloomfield Hills City Code or under Section 750.535 of the Michigan Compiled Laws shall not be permitted to operate as a dealer within the city for a period of five (5) years after conviction.
- An application fee of \$50.00 is required at the time this application is submitted.
