V. LICENSING REQUIREMENT

Section 106.4 of the Plumbing Code as adopted requires that a contractor licensed under 2002 PA 733, MCL 338.3511 apply for a permit to erect, alter, install, enlarge, repair, remove, convert or replace a plumbing system regulated by this code. Section 23a of the state construction code act of 1972, 1972 PA 230, MCL 125.1523A, prohibits a person from conspiring to circumvent the licensing requirements of this state relating to persons who are to perform work on a residential building or residential structure. Violators of Section 23a are subjected to civil fines.

VI. HOMEOWNER AFFIDAVIT

I hereby certify the work described on this permit application shall be completed **by myself in my own home** in which I am living or about to occupy. All work shall be completed and/or installed in accordance with the State Building Code and **shall not be** put into use until it has been **inspected and approved** by the Plumbing Inspector. I will cooperate with the Plumbing Inspector and assume the responsibility to arrange for necessary inspections.
